
UIIA Motor Carriers wishing to access the UIIA application have two options to login:

### 1<sup>st</sup> Option to Log Into the UIIA for Motor Carriers:

Go to the top of the page and hover over the drop down menu titled "LOGIN INTO YOUR ACCOUNT".

## Help Guides/Tutorials/FAQs



To get to the Motor Carrier Help page:


Hover over the dropdown menu at the top of the page "HELP GUIDES & WEBINARS".

This takes the user to a page that contains general Motor Carrier help tools. User would just select the help item they are looking for.




### **Motor Carrier General Help Page**



To promote intermodal productivity and operating efficiencies through the development of uniform industry processes and procedures governing the interchange of intermodal equipment between ocean carriers, railroads, equipment leasing companies and intermodal trucking companies.

### BENEFITS OF UIIA PARTICIPATION

- Eliminates signing separate interchange contracts with each UIIA equipment provider.
- Reduces the number of insurance certificates that a Motor Carrier is required to file with each Equipment Provider
- Provides a web interface to access motor carrier interchange status information to confirm your company's validity with specific UIIA Equipment Providers before dispatching drivers.
- Allows for online insurance submission by authorized agents 24 hours a day/7 days a week
- Furnishes automated thirty and seven-day insurance expiration reminders to advise Motor Carriers of upcoming insurance renewals.
- Provides continuity and a "personal" approach to resolving issues quickly by having dedicated Customer Service Representatives available as well as extended customer service hours from 8:00 a.m. to 8:00 p.m.
- Offers access to IANA's Street Interchange Application (SIA), which provides a web portal to facilitate street interchanges/street turns and captures an electronic record of these transactions.
- Expedites the interchange process by ensuring Motor Carrier interchange status information is provided directly to terminals, container yards and depots on behalf of Equipment Providers that subscribe to IANA's Terminal Feed Service.
