

# Overview of IANA's Street Interchange Application

## IANA's Street Interchange Application

- Web Portal to facilitate EP approved Motor Carrier to Motor Carrier street interchanges/street turns under the UIIA.
- EPs and MCs will be able to access the street interchange application once logged into their UIIA account.
- Value added, no cost benefit to UIIA participants.
- UIIA MCs can immediately begin using the service for those EPs that have elected to utilize the SIA application for performing street turns and street interchange transactions.
- Communication method to receive notices from the Street Interchange application by default will be set to e-mail and the UIIA master contact on file. Other methods of communication available are EDI, XML or API.

## IANA's Street Interchange Application

- **Benefits of the application for UIIA participants include:**
  - Establishes an efficient communication process between MCs and UIIA EPs to expedite the street interchange/street turn process.
  - Provides automatic validation to confirm MC B has a valid UIIA interchange with the EP(s) involved in the street interchange transaction.
  - Captures electronically the transfer of liability, damage and indemnification set forth under the UIIA from Motor Carrier A to Motor Carrier B when the street interchange is performed or when unit changes from import to export move for street turn transaction.
  - Provides for better utilization of intermodal equipment resulting in a savings for drivers as it relates to mileage and fuel.
  - Provides supporting documentation that can be used to ensure an EP's free time and per diem as been allocated properly based on the terms contained in the EP's UIIA addendum as well as maintenance and repair charges.



## UIIA Enhancements Street Interchange Application

Based on user feedback, the following enhancements have been introduced:

- **New Quick Street Turn** feature has been added to streamline requests by Motor Carriers that want to re-use an import container for an export move.
- **New Edit, Cancel and Re- Initiate** functionalities have been introduced to allow users more flexibility with street interchange requests.
- **Multiple Containers/Single Request** – The ability to add multiple containers under a single Quick Street Turn request will also be available.
- **Expanded Timeframe** – The 24 hour clock before a transaction is rejected will be expanded for requests initiated on a Friday after 2pm. The clock on these requests will not start until Monday at 7am precluding these transactions from being rejected prematurely before the parties have time to respond.
